

Information a Covid -19 Emergency

(Pursuant to paragraph 1 of the shared regulatory protocol of measures to combat and contain the spread of the Covid-19 virus in the workplace of 14/03/2020)

This document was drawn up by the company **MARINA dello STRETTO S.r.l.** in order to inform all employees, users, consultants, external technicians, suppliers, visitors and anyone entering the legal or operational headquarters, about the actions taken to contain the spread of the Covid-19 virus in the work, in compliance with paragraph 1 of the shared protocol regulating the measures to combat and contain the spread of the Covid-19 virus in implementation of art. 1, first paragraph, number 9), of the Prime Ministerial Decree of 11 March 2020.

In particular, we inform you that:

- It is mandatory to stay at home in the presence of fever (over 37.5 ° C) or other flu symptoms and to call your family doctor and health authority;
- The staff, users, customers, external technicians, suppliers and anyone who wants to access the places of MARINA dello STRETTO S.r.l. will be subjected to body temperature control. If this temperature is higher than 37.5 °, he will not be allowed access. Persons in this condition - in respect of privacy - will be temporarily isolated, they will not have to go to the emergency room and / or the infirmaries of the office, but will have to contact their doctor as soon as possible and follow his instructions or, in any case, the health authority;
- They are aware and accept that they cannot enter or remain in the company and that they must promptly declare it where, even after entry, dangerous conditions exist (symptoms of flu, temperature, coming from areas at risk or contact with people positive to the virus in the previous 14 days, etc) in which the provisions of the Authority require you to inform the family doctor and the Health Authority and to remain at home;
- They undertake to comply with all the provisions of the Authorities and of the company when accessing the company and the places it manages (in particular, keeping a safe distance, observing the rules of hand hygiene and maintaining correct behavior in terms of hygiene);
- The worker / consultant undertakes to promptly and responsibly inform the employer of the presence of any flu symptoms during the performance of the job, taking care to remain at an adequate distance from the people present;

- It is absolutely forbidden to enter the premises of MARINA dello STRETTO S.r.l. lacking the necessary protective devices to prevent contagion such as MASK AND GLOVES;
- While access to third parties is reduced as far as possible, if entry is necessary, by appointment, their commitment remains to comply with all company rules, including those for access to the company. The number of people inside the company premises may be limited until the end of the state of emergency;
- The recipients of this communication assume full responsibility, including of a criminal nature, for the absence of the conditions impeding access indicated above. As regards the processing of personal data for the purposes related to this communication, please refer to the Information for suppliers (pursuant to Article 13 of EU Regulation 2016/679);
